- WHERE:** RAY KROC COMPLEX/DESERT SUN STADIUM, 3500 S. AVENUE A., YUMA, AZ
- PRODUCT/PREMISES:** Vendors must sell a tangible product on the premises. All merchandise and display material must remain inside the 20 x 20 assigned space. NO SUBLETTING ALLOWED.
- SELLING OPPORTUNITIES:** Friday, March 6, 2020 12:00 p.m. to 11:00 p.m.
Saturday, March 7, 2020 9:00 a.m. to 11:30 p.m.
Sunday, March 8, 2020 9:00 a.m. to 1:00 p.m.
Please be set up, with attendants in your booth, at the designated times. See "Power Schedule" below.
- COST/SPACE SIZE:** 20' X 20' = \$350.00 per Space ON MAIN FIELD
20' X 20' = \$250.00 per Space OFF MAIN FIELD
Because of limited space on the Main Field, space will be assigned at the discretion of the MATO Vendors Committee. This is an outdoor event. Tables, chairs, extension cords and booth frames will not be provided.
- SETUP/CHECK IN:** Thursday, March 5, 2020 10:00 a.m. to 6:00 p.m.
ALL VENDOR VEHICLES/TRAILERS MUST BE OUT OF STADIUM BY 6:30 PM, THURSDAY.
Handcarts/wagon are recommended getting merchandise/supplies to booths any time after Thursday
Overnight security will be provided Thursday, Friday and Saturday nights.
- POWER HOOKUPS:** (110v, 20 amps) ARE PROVIDED. VENDOR MUST PROVIDE UL APPROVED HEAVY DUTY EXTENSION CORDS. NO GENERATORS ALLOWED. General area lighting will be provided, but auxiliary lighting is recommended. Be sure speakers are not so loud as to be offensive to those in surrounding area.
- POWER SCHEDULE:** Friday, March 6, 2020 10:00 a.m. to 11:30 p.m.
Saturday, March 7, 2020 8:00 a.m. to 12:00 midnight
Sunday, March 8, 2020 8:00 a.m. to 1:30 p.m.
- PASSES:** Each vendor space includes 2 (two) passes. Additional passes are \$25.00/each.
- TEAR DOWN:** Sunday, March 8, 2020 1:00 p.m.
Vendors will not be permitted to tear down or bring vehicle(s) onto stadium before 1:00 p.m.
- BANNERS/SIGNS:** One (1) – 2' x 10' Maximum
- HEIGHT:** 15' Maximum (includes shades, flags, balloons, etc)
- RAIN OR SHINE:** **EVENT WILL BE HELD RAIN OR SHINE. NO REFUNDS.**
- RAFFLES/DONATIONS OR RAFFLE TICKETS:** NO SOLICITATIONS WILL BE CONDUCTED OR RAFFLE TICKETS SOLD by individuals, groups, vendors and/or sponsors, other than by the Caballeros de Yuma, Inc, during Midnight at the Oasis at Ray Kroc Complex/Desert Sun.

The set-up and tear-down times are noted on the application. Please note: Check-in will be on Thursday, March 5, 2020 - one day only.

MIDNIGHT AT THE OASIS is a nostalgia festival, featuring classic cars from 1972 and older, two nights and 1 afternoon of concerts plus tons of fun for the entire family. In 2019, 900 classic car owners gathered in Yuma to show off their prized possessions to the more than 50,000 spectators that roamed over four regulation baseball fields that were used as the Spring Training home of the San Diego Padres. The festival continues to be one of the premier events of its type in the Southwest.

MIDNIGHT AT THE OASIS is held in the beautiful grassy Desert Sun Stadium/Ray Kroc Complex and adjacent to the Yuma Civic Center, the Desert Hills Municipal Golf Course, and Caballeros' Park.

There will be no RV or vehicle overnight parking on Thursday, Friday or Saturday nights in the Ray Kroc Complex/Desert Sun Stadium public parking area.

Please return application as soon as possible. You have a choice of "On the Main Field" or "Off the Main Field." However, because of limited space on the Main Field, space will be assigned at the discretion of the MATO Vendor Committee. Consideration will be given to vendor's previous participation in MATO and quality of operation, as well as date of receipt of Vendor Application in the office of the Caballeros de Yuma. **Payment in full & copies of liability & workers comp insurance must accompany application for consideration.**

All vehicles must be off grounds by 6:30 pm Thursday. Registration packets may be picked up from the Vendor Chairman between 10 am to 6 pm Thursday at the Ray Kroc Complex. **NO CHECK IN WILL BE PERMITTED ON FRIDAY, MARCH 6.**

ELECTRICAL: 110 volt/ 20 amp service provided, use UL approved heavy extension cords only. General area lighting will be provided, but auxiliary lighting is recommended. NO GENERATORS ALLOWED.
